

F) To provide necessary facilities to excell in games and sports.



4. GENERAL BODY

- i) All the members shall form the general body of the society which number shall not be less than 7 in any case.
- ii) The following, among others are functions of the general body:

- i) The managing committee shall consist of not less than 7 members and not more than 12 members. The managing committee shall be elected by the General Body every year by a majority decision.
- ii) The following shall be the office bearer of the managing committee:



iii) The following shall be the functions of the Managing Committee :

- a) to consider the applications for membership.
- b) to appoint, sue, terminate or dismiss employees and to decide the terms of the employees.
- c) to raise loans and deposits and decide the terms and conditions on which these should be accepted.
- d) to acquire in the name of society by gift, purchase, exchange, lease, hire any land, building, rights or privileges for the society.
- e) to build, construct, maintain, alter, extend, improve and repair any building or premises of Society.
- f) to make from time to time or amend the rules and regulations of the society.
- g) to delegate any powers of the Managing Committee to any office bearer.
- h) to do all such acts and things as are incidental to the attainment of the above powers.

6. MEETINGS:

- i) The general body of the society shall meet once in a year positively and notice will be issued to this effect by the secretary atleast fifteen days prior to the meeting. The date, time and place of the annual meeting will be fixed by the chairman.
- ii) The majority of the members can also requisition a general body meeting and on such requisition, the chairman shall call a meeting of General Body after getting the notice issued to all the members.

iii) The Managing Committee shall meet once in three months or earlier. The Secretary shall issue a notice to the members atleast seven days prior to the date. The emergency meeting of the Managing Committee shall be called with only 24 hours notice whenever deemed necessary to discuss some important agenda.

iv) One Half of the total members of Managing Committee as well as General Body will form the quorum.



iii) No profit shall be taken by any of its members out the society. However, the member shall be entitled to actual expenses incurred on travelling, boarding and/or lodging for attending to any outdoor work of the society.

iv) All disputes, suits or claims shall be sued or filed in the name of the Secretary of the society and he shall be entitled to look into the disputes and engage counsels or file replies to defend in the name of the society and all expenses incurred by him shall be reimbursed to him.


